

DriveGuardian Bravo Installation Instructions

Preparing for Installation

DriveGuardian replaces the factory coupler that is mounted to the flywheel so it will need to be removed prior to installation. Please see your engine manufacturer's instruction manual for directions on how to gain access by removing the driveline/transmission & bellhousing.

Installation and Alignment

DriveGuardian installation requires that the engine alignment be very precise. Any misalignment will make installing the drive difficult and must be corrected. Attempting to install the drive using force or by tightening the bolts to draw it on will cause damage to the coupler and/or gimbal bearing and will void the warranty.

- Be sure the mating surface of the flywheel is clean. Please note that DriveGuardian cannot be installed on an aluminum flywheel without modification to clear the crankshaft bolts. Please contact Marine Design Corporation with any questions or to arrange having the unit machined to fit.
- 2. DriveGuardian is attached to the flywheel using (6) shouldered bolts to ensure alignment with the crankshaft. Be sure to use the OEM bolts and washers from the stock coupler or alternatively use ARP Pressure Plate Bolts part number 130-2201 that can be obtained at most performance automotive outlets.
- 3. Using a crisscross pattern, incrementally tighten the six mounting bolts. Once seated they should be torqued to 35 ft-lbs.
- 4. Apply spline grease to the input shaft of the drive. The grease will not be able to reach the clutch plates.
- 5. When installing the drive it should slide on with minimal force. The coupler end of the Mercury alignment tool is significantly smaller than the I.D. of the stock coupler and DriveGuardian so it is possible that the alignment tool will fit but the drive does not slide all the way on. If this occurs then the alignment needs to be adjusted until the drive can be easily installed.
